Treasurer's Report Lee Syria

L. Syria: Serving as Treasurer. During past year, board decided to set up a finance committee. In the past the finances were handled by the Executive Committee, but they've been freed up to do other work. Assets up \$90K, Liabilities up by \$6K, Investments of \$617K, \$1.1 million, Revenues up 80K, expenses up over 100K as we were up to full staff. Net assets for 2016 at \$83K.

Revenue: 84% from Member Dues in 2016. Expenses: 61% from salaries and benefits.

2017 Annual budget looks very much like 2016.

Financially we're strong and stable with over \$600K in reserve.

 $\label{eq:market_state} \textbf{M. Readinger: Market value of UCF is up by $20k in the last two months. Trend in Dues revenue is that 100×10^{-10} and 100×10^{-10}.}$

as a percent of total revenue is generally dropping over time.

Franklinton Center at Bricks – 270- acre former slave plantation turned into conference, retreat and education center. Originally one of the first schools for African Americans in the south. Serve local community in poor rural area of North Carolina. 65 kids per week work in the fields and they learn about farming, gardening, cooking, canning, etc. Food pantry, literacy project, summer enrichment and after school tutoring, adult literacy, technology enrichment, family mental health support, migrant support, parent support. Were brought into covenant with the conference and provisional membership with CHHSM by the board back in November.

Joint Neighborhood Ministries – Benton Park neighborhood. Served over 15k people in 2016. Food pantry, senior disabled food delivery program, for those 60 years at least old and homebound. Receive one food delivery per month but they also get a visit and a wellness check to make sure there are no

other health issues. Payee for representative for social security benefits. Act as a fiscal agent and assist with budgeting and financial management. Urban mission experience program, through Epiphany church, experience homelessness for 1 day or 1 week. In covenant with MOMS and accepted by the CHHSM board as provisional member.

All informed by the Value Proposition developed last year

Developed a new strategic plan that will drive work for the next 3 years

- Membership Expansion As an association with only corporate members we want to expand
 membership to individuals (this is something they used to do in the 80s). Many organizations
 are aligned with other faith traditions that don't have a CHHSM equivalent, so want to explore
 affiliation membership to afford the opportunity for communion.
- Leverage the members to give greater benefit through closer association.
- Membership and leadership engagement want to bring CHHSM to where you are for greater community and association.
- Continue efforts with engagement with the UCC National Setting and Wider Church.
- Want to do more with Nollau and leadership education. Try to figure out how to expand and do
 work together in community. Need to make the leadership training more accessible to direct
 care staff. Nollau 2 You in day long program.
- Advocacy Want to figure out how to gather the thoughts and ideas everyone has about advocacy and have that inform the rest of our work.

New website coming in a few weeks, new newsletter and marketing/communications, request for videos of what creating a just world means to you.

Questions

N. Joseph: How much does individual membership cost? M. Readinger: Not yet determined.

N. Joseph: Would like us to consider lifetime memberships for individuals.

L. Olsen: Is running retreats for management, but would like to find a way for them to have training at their facility, ½ day on a quarterly basis. M. Readinger: Nollau 2 You is geared toward direct care staff. C. Bumb: Wants their direct care staff to have a greater understanding of what servant leadership is. L. Olsen: Wants to be sure managers are trained and then take it deeper into the staff. D. Bartz: Creating a

leadership advisory committee for the BOD. If you're interested in working on the committee let her know.

K. Daniel: What is being planned for the Website? B. Guess: Sharing documents, greater sharing of stories as the stories of the UCC, deliver information directly to the UCC, stop relying on the National Setting to share our stories. New Facebook page is geared toward sharing stories with the wider church.

C. Bumb: Membership question: Isiah 51 and Community Union Ministry are both founded from UCC Churches but more ecumenical. Could we open membership to organizations that are associated with more than one denomination? M. Readinger: We have others that are ecumenical. C. Bumb: They probably don't want to be full members with the dues. M. Readinger: Many would only pay \$250 in dues, which still may be too much, but many don't have other organizations to belong to.

- S. Brooks-Cope: Advocacy, they want to do something to help but need information, what letters to write, which calls to make, etc. M. Readinger: It's a challenge, but we don't want to be overwhelming the membership with too many emails. Gayle: Put information on website.
- B. Guess: Development of Age-Friendly Congregations curriculum, companion to ONA.
- D. Bartz: Announced GS2017 Resolution about gun violence as a public health issue.
